In exercise of the powers conferred by Section 41 of Kerala Panchayat Raj Act, 1994 (13 of 1994), the State Election Commission, Kerala, hereby make the following amendments to the Notification No.192/2020/SEC dated 20<sup>th</sup> August, 2020, published in the Kerala Gazette Extraordinary No.1894, dated 20<sup>th</sup> August, 2020, namely:-



#### **AMENDMENT**

In the said notification, under the heading "THRISSUR DISTRICT" against Sl.No.84, the entries against column No.4, the following entry shall be substituted, namely:-

"Secretary, District Panchayat, Thrissur"

#### EXPLANATORY NOTE

(This does not form part of the notification, but is intended to indicate its general purport.)

As per Notification No.192/2020/SEC dated 20<sup>th</sup> August, 2020 issued by the State Election Commission by virtue of its powers under section 41 of Kerala Panchayat Raj Act, 1994, the Executive Engineer, NH(B) Division, Kodungallur was designated as Returning Officer for B84 Mathilakam Block Panchayat in Thrissur District. Now, it is reported that the said office has discontinued and also requested to designate Secretary, District Panchayat, Thrissur as the new Returning Officer. Accordingly, the District Election Officer, Thrissur has submitted a proposal to nominate "Secreatry, District Panchayat, Thrissur" as the Returning Officer for B84 Mathilakam Block Panchayat. Hence this amendment is necessitated.

This notification is intended to achieve the above object.
