#### EXPLANATORY NOTE

(This does not form part of the notification, but is intended to indicate its general purport)

As per Notification No. 23/2025/SEC dated 23<sup>rd</sup> August, 2025 issued by the State Election Commission by virtue of its powers under section 41 of Kerala Panchayat Raj Act, 1994, the District Forest Officer (North Division), Nilambur was designated as Returning Officer of B.105 Nilambur Block Panchayat and District Forest Officer (South Division), Nilambur was designated as Returning Officer of B.107 Wandoor Block Panchayat respectively, in Malappuram District. Now, the District Election Officer, Malappuram reported that, the above designations were suggested erroneously and submitted a proposal for changing the nomenclature of office by amending the said notification. Hence this amendment is necessitated.

This notification is intended to achieve the above object.
