EXPLANATORY NOTE

(This does not form part of the notification, but is intended to indicate its general purport.)

As per Notification No.25/2025/SEC dated 23rd August, 2025 issued by the State Election Commission by virtue of its powers under section 97 of the Kerala Municipality Act, 1994 (20 of 1994), the Executive Engineer, BSP Division, Padinjarathara was designated as Returning officer of Wards 1 to 37 of M 81 Mananthavady Municipality. The District Election Officer, Wayanad as per letter dated 04.10.2025 has requested to appoint Executive Engineer, Karapuzha Project Division, Kalpetta as Returning Officer, in addition to the present incumbent, for the smooth conduct of the election. Hence it is decided to appoint Executive Engineer, Karapuzha Project Division, Kalpetta as Returning Officer, in addition to the present incumbent and to divide the work among them.
