In exercise of the powers conferred under Section 41 of the Kerala Panchayat Raj Act, 1994 (13 of 1994), the State Election Commission hereby make the following amendment to the notification No. 193/2020/SEC dated 20th August, 2020 and published in the Kerala Gazette extraordinary No. 1895 dated 20th August, 2020, namely:-



AMENDMENT

- In the said notification,
- (i) in serial number 431, in the entry against it in Column 4, the words "Employment Officer Town Employment Exchange, Tripunithura" shall be substituted;
- (ii) in serial number 529, in the entry against it in Column 4, the words "Special Tahsildar (Land Reforms), Thrissur" shall be substituted;
- (iii) in serial number 770, in the entry against it in Column 4, the words "Assistant Educational Officer, AEO Office, Perambra" shall be substituted.

EXPLANATORY NOTE

(This does not form part of the notification, but is intended to indicate its general purport)

As per notification No. 193/2020/SEC dated 20th August 2020 issued by the State Election Commission by virtue of Section 41 of Kerala Panchayat Raj Act, 1994, the Special Tahsildar (LA), KRL, Tripunithura; Special Tahsildar (Land Records), Thrissur and Senior Superintendent, AEO Office, Perambra have been designated as Returning Officers of G.42 Udayamperoor Gramapanchayat, G.60 Paralam Grmapanchayat and G.32 Koothali Gramapanchayat respectively. The District Election Officers concerned have submitted a revised proposal for replacing those officers.

This notification is intended to achieve the above object.
