ORDER

The State Election Commission is constituted under Articles 243 K and 243 ZA of the constitution of India for the superintendence ,direction and control of the preparation of the electoral rolls for, and the conduct of all elections to the Panchayats and Muncipalities in the State. Apart from it, being a constitutional functionary, the Commission also provides internship for aspiring law students. For so long such training has been provided in a conventional way. Considering the pandemic situation and to bring new perspective to problem solving, the Commission has decided to revamp the internship programme provided to law students in a timely manner. Therefore the following instructions are issued to those law students , who desires for internship in Kerala State Election Commission , and college principals thereof.

Each student shall prepare and submit assignments on the topics assigned to him. (Topics of assignment are attached herewith as Annexure) College Principal shall assign one or more topics to each student. Each student shall acquaint with the topic intensively and extensively, with special emphasis to legal issues involved and its remedy. The students shall gain field level experience by visiting heads of local bodies, Secretaries of local bodies, Electoral Registration Officers, Returning officers etc. They shall critically examine whether election activities being carried out are in accordance with law. After familiarizing with the topic each student shall prepare an assignment on the topic or topics assigned to him. Everything such as study, field visit, interaction with concerned etc will form part of the record of assignment and submit the assignment to College . College shall verify it contents, its arrangements etc and after satisfying its contents, arrangements etc, College shall forward the assignment to Commission, along with his recommendations. If he is not satisfied with the assignment it shall be returned to the student for re- submission. College principal shall also recommend the number of days (maximum 15 days) taken by each student for completing the work. Commission, after evaluating the assignment submitted by each student, will issue certificate of internship to the students through college Principal.

The students shall adhere to the existing Covid 19 protocol throughout the internship program and while conducting visits.

These instructions are applicable to all pending applications for internship as well as new applications
