EXPLANATORY NOTE

(This does not form part of the notification, but is intended to indicate its general purport :)

As per Notification No. 192/2020/SEC dated 20th August, 2020, which was published in the Kerala Extraordinary Gazette No.1894 dated 20th August 2020, the State Election Commission, in consultation with the Government of Kerala, had designated, among others, Assistant Director of Panchayats and Assistant Development Commissioners as Returning Officers of Block Panchayats. Consequent to the integration Departments into Local Self Government of five Department, GO(MS)No.134/2022/LSGD, dated 25/06/2022, the post of Assistant Director of Panchayats and Assistant Development Commissioner have been re-designated as Assistant Director, LSGD. In view the change in nomenclature of posts, the Government of Kerala, as per letter No.EM3/22/2023/LSGD dated 13.07.2023 submitted proposals for amending Notification No.192/2020/SEC dated 20th August, 2020. Hence these amendments are necessitated.

This notification is intended to achieve the above object.
