Late tenders will not be accepted. Tenders will be opened at 3.00 p.m. on.23/7/2024..The rates quoted should be inclusive of all taxes applicable and the delivery charges and installation charges. Tender will be opened in the presence of the tenderers or their authorized representatives on the same day. They shall submit the proof of identity/authorization letter at the time of opening. The date for opening of tenders may be varied as per the discretion of the State Election Commission.

Tender should be accompanied by EMD (2.5% of the total tender value) and in the form of DD drawn in favour of the "Secretary, State Election Commission". The EMD of unsuccessful bidders will be refunded. The tenderers / bidders shall enter into a contract with State Election Commission incorporating all the clauses of tender. The successful bidder has to produce a security deposit equal to 5% of the total quoted value. Delivery of the article should be made at free of cost to State Election Commission office within 5 days from the receipt of supply order.

Payment will be made only after successful installation of the items and no advance payment shall be permitted under any reason whatsoever.
